

Healthcare shines

- Healthcare and Consumer Staples outperform global markets in August
- Healthy Living fund slightly underperforms global markets
- US consumer sentiment fell in August fueled by concerns on higher prices

Market review and developments

In August, the global market delivered positive returns, driven by the Materials, Healthcare and Consumer Discretionary sectors. Both the Healthcare and Consumer Staples sectors, which together account for three quarters of the Healthy Living portfolio, generated positive returns and outperformed the broader market. The Information Technology sector, which is the largest sector in the MSCI World Index, underperformed, while the Utilities sector was the only sector which generated negative returns in the month.

After strong share price corrections in Managed Care companies as well as obesity drug manufacturer Novo Nordisk which had weighed heavily on global Healthcare sector performance in July, the subsequent rebound in their share prices supported strong performance of the sector in August. Similarly, within Consumer Staples, the reversal in share price development of heavy weights such as Nestlé and Procter & Gamble, supported sector performance.

In August 2025, the University of Michigan Consumer Sentiment Index fell to 58.2, a 5.7% decline from July and the first decline in four months, primarily due to heightened concerns about the economy and rising inflation. While the index remains 11% above April and May levels, the decline in sentiment in August was visible across demographic and income groups. In particular, buying conditions for durable goods fell to its lowest reading in a year, and over 40% of consumers spontaneously mentioned high prices eroding their purchasing power, a higher share than in previous months. Finally, the market is eagerly waiting for the Bureau of Labor Statistics' jobs data for August after the US job market slowed substantially in July and job figures from May and June were drastically revised downwards. Unemployment rate is expected to tick slightly higher, while change in payrolls are expected to be modest month over month.


In late August, Eli Lilly announced promising results for its once-daily GLP-1 agonist pill, orforglipron, which achieved over 10% body weight reduction in adults with type 2 diabetes and overweight. The pill's flexible dosing, without restrictions on food or water intake, may offer convenience for some patients. However, Novo Nordisk continues to lead the race to oral weight loss drugs, as it announced in May the submission of an FDA application for its oral semaglutide, a peptide-based therapy for weight loss. While it requires administration on an empty stomach first thing in the morning, oral semaglutide builds on the success of Novo Nordisk's injectable GLP-1 treatments, offering patients a trusted alternative in oral form.

Performance

Last month's performance

In August, the Healthy Living Fund slightly underperformed the broad global benchmark and its investable universe. Two of the fund's four clusters generated positive returns. Healthcare Efficiency was the strongest performer, followed by Healthy Lifestyles. Healthy Nutrition delivered negative returns while Therapeutics was only slightly negative.

At the individual stock level, the biggest positive contributor in August was managed care player United Health, which rose on news that Warren Buffet's Berkshire Hathaway had taken a stake in the company. In July, the company had reinstated a full year guidance, providing highly needed visibility to the market, after a disappointing second quarter earnings report.

The second-largest positive contributor was provider of government health services, Maximus, which saw a strong recovery in August, as confidence in mid-term growth trajectory returned after encouraging management comments on next year's expectations. Market sentiment has been gradually improving since the company suffered from a correction in share price after the US elections due to fears of loss of federal contracts.

The largest negative contributor in August was protein shake company, Bellring Brands, which saw a sharp share price correction despite delivering a strong quarter, with double digit percentage growth in consumption of its ready-to-drink shakes. Management's refusal to provide guidance for the next financial year, starting on October 1st, and statements on heightened competition spooked the market.

The second-largest negative contributor was vision care company Alcon, after quarterly earnings came below market expectations for the second time this year. Notably, growth in surgical procedure volumes slowed down and competition intensified. The company also cut its full year guidance as a result of the disappointing quarterly results.



Portfolio changes and positioning

During the month, we trimmed our position in Biomérieux, as valuation fully reflects a favorable outlook in its molecular diagnostics business.

In terms of positioning, the fund is overweight versus its investable universe in Food Products and Natural Food & Ingredients, where we favor suppliers of healthier food options and companies innovating to make food healthier. The fund is also overweight in Diagnostics & Prevention. On the other hand, it is underweight in Personal Care & Hygiene, Physical Activity & Recreation, and Healthcare Infrastructure.

The risks to economic growth have increased due to inflation, geopolitical tensions, and the economic imbalances in China.
